# EXPRESSION OF INTEREST FOR SERVICES

## 1.0 INTRODUCTION

- 1.1 The Board and Management of the Niger Delta Development Commission (NDDC) in line with its statutory mandate and the Niger Delta Regional Development Master Plan (NDRDMP) wishes to procure various services in the mandate nine (9) States of the region. The full list of the intended goods to be procured is as shown below.
- 1.2 Consequently, the Commission wishes to engage the services of experienced and qualified consultants to undertake the procurement of the services listed below.

## 2.0 SCOPE OF SERVICES

2.1 The scope of services to be rendered are as indicated against each or group of similar services contained in the attached list.

## 3.0 ELIGIBILITY CRITERIA:

- 3.1 This Expression of Interest (EoI) shall be based on meeting the following minimum eligibility criteria:
  - a. Evidence of registration with Corporate Affairs Commission (CAC) by inclusion of Certificate of Incorporation and Article of Association;
  - b. Detailed Company Profile;
  - c. Evidence of current Tax Clearance Certificate (for the last three years) corresponding with the declared Annual Turnovers by inclusion of photocopy;
  - d. Evidence of Compliance with the Pensions Reforms Act, 2004 by inclusion of Compliance Certificate from the National Pension Commission;
  - e. Evidence of Compliance with the Social Insurance Fund Amendment Act, 2011 by inclusion of Compliance Certificate from the Social Insurance Fund;
  - f. Evidence of Compliance with the Industrial Training Fund Amendment Act, 2011 by inclusion of Compliance Certificate from the Industrial Training Fund;
  - g. Evidence of Registration in the National Database of Contractors, Consultants and Service Providers by attaching the Interim Registration Report from BPP.
  - h. Evidence of relevant work experience in at least three (3) jobs of similar nature and complexity executed within the last five (5) years with verifiable Award letters and Certificates of Payments or Job Completion;
  - i. Evidence of possession of Financial Capability by inclusion of the declared Annual Turnovers for three (3) years and as related to the Firm's Audited Accounts;
  - j. Evidence of possession of adequate and qualified personnel to execute the work by inclusion of their resumes, qualifications and professional certificates;
  - k. Evidence of possession of the relevant Equipment, Instruments, Warehouse or/and other relevant facilities where necessary;
  - 1. Affidavit that the firm is not in receivership, insolvency or bankruptcy;
  - m. Affidavit that none of the directors of the company has any criminal conviction relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts;
  - n. Affidavit that none of the directors of the company are officers of the Federal Service or BPP;
  - o. Compliance to other specific requirements relevant to the intended procurement.
